

T/C® Compass® Get Out And Shoot Sweepstakes

Official Rules

1. **NO PURCHASE NECESSARY.** NO PURCHASE, PAYMENT OR OTHER CONSIDERATION IS NECESSARY TO ENTER OR WIN A PRIZE IN THIS SWEEPSTAKES.
2. Description of Sweepstakes. In the “T/C® Compass® Get Out And Shoot Sweepstakes” (the “Sweepstakes”), Smith & Wesson Corp. (“Sponsor”) will award one prize immediately following the close of the Sweepstakes Term (defined below). A total of one (1) T/C® Compass® rifle in .204 Rug (SKU 10070), one (1) BOG-POD® RSR (Rapid Shooting Rest) (SKU 110113) and one (1) Caldwell® Tack Driver® Shooting Bag (SKU 569230) will be awarded. The approximate total retail value of the prize awarded is \$503.98.
3. Sweepstakes Term. **The Sweepstakes begins on August 4th, 2017 at 12:00 p.m. (EST) and ends on August 31st, 2017 at 11:59 p.m. (EST)** (the “Sweepstakes Term”). All entries must be submitted via Facebook® Sweepstakes Application or via email during the Sweepstakes Term in accordance with these Official Rules to be eligible to win. Limit one (1) entry per person during the Sweepstakes Term regardless of the method of entry. Entries that do not comply with these Official Rules will not be accepted.
4. How to Enter.
 - A. Primary Method:

Via Facebook: To enter the Sweepstakes via Facebook, entrants must: (1) sign into their Facebook accounts, (2) visit the official Thompson/Center Arms Facebook page, (3) go to the T/C® Compass® Get Out And Shoot Sweepstakes Application, (4) “Like” Thompson/Center Arms Facebook Page, (5) share Sponsor’s T/C® Compass® Get Out And Shoot Sweepstakes Post, and (6) complete and submit the information required on the official T/C® Compass® Get Out And Shoot Sweepstakes entry form.

Or
 - B. Alternate Method:

Via Email: To enter the Sweepstakes via email, send an email to sweepstakes@smith-wesson.com with “T/C® Compass® Get Out And Shoot Sweepstakes” in the subject line. An email entry must include entrant’s first and last name, address, email address and date of birth.
5. Odds of Winning. Odds of winning a prize depend on the number of valid entries received. **Many will enter, one will win.** Only one (1) prize will be awarded to any one winner.
6. Eligibility. You must be 21 years of age and a legal U.S. resident to enter. Additional eligibility requirements are set forth in these Official Rules. Employees of Sponsor and its agents, affiliates, and subsidiaries and members of their families and immediate households are not eligible to participate in this Sweepstakes. All eligible entries will be included in a random drawing for the prize. All federal, state and local laws and regulations apply.
7. Winners. The prize winner will be selected by random drawing once immediately following the close of the Sweepstakes Term. The prize winner will be notified by Facebook message or by email

(depending on method of entry). The prize winner must respond to Sponsor via private message (Facebook message), or by an email response to the email notification from Sponsor, with the prize winner's name, address, phone number, and email address within forty-eight (48) hours of the direct reply comment notification or email from Sponsor to claim the prize. Prize winner must be eligible to own and possess a firearm in their state of residence; where applicable, must possess any required firearms permits/licenses for ownership and possession of the firearm portion of the prize; and must pass a background check to be eligible (i.e., must not be a "prohibited person" under applicable laws). The firearm portion of the prize package will be awarded through a participating federally licensed firearms dealer retailer closest to the winner's official residence and will not be shipped directly to the winner. Prize winner may be required to demonstrate eligibility in accordance with these Official Rules and complete an affidavit of eligibility and release of liability to be eligible to claim and receive the prize. If for any reason Sponsor is unable to contact the prize winner, or the prize winner fails to timely respond or is ineligible, the winner's prize will be awarded in a random drawing to another eligible entrant. Sponsor, and its agents, affiliates, and subsidiaries, may use the prize winner's name, likeness and any other information or content without compensation in advertising or otherwise.

For firearm portion of prize package, sponsor is responsible only for delivery to a participating federally licensed firearms dealer closest to the winner's official residence. Sponsor is not responsible for prize utility, quality or other attributes. No prize is transferable or assignable to another party.

By entering into this Sweepstakes, you grant to Sponsor an irrevocable, perpetual, worldwide, non-exclusive, royalty-free, sub-licensable right and license to distribute, reproduce, modify, perform and display and otherwise use any and all content, information, posting, communication, message or other materials (including your name, image or likeness) provided by you ("Sweepstakes Materials") for Sponsor's use in the normal conduct of its business, including marketing, promotional and sales activities. Sponsor assumes no responsibility for any incomplete, misdirected, late, or lost entries, or any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, garbled or corrupted data transmitted, inaccessibility of any entry website, theft or destruction or unauthorized access to, or alteration of, entries or entry data, telephone, cable, satellite, network, electronic or Internet connectivity or other online or telephone network communication problems, errors or limitations of any Internet or telephone service providers, servers, hosts or other providers, failure of any online transmissions to be sent or received, or traffic congestion on the Internet or any entry website. If, for any reason, the Sweepstakes is not capable of running as planned, including tampering, unauthorized intervention, fraud, or any other causes beyond the control of the Sponsor which affects the administration, security, fairness, integrity or proper conduct of the Sweepstakes, then Sponsor reserves the right at its sole discretion to cancel, terminate, modify or suspend the Sweepstakes. In the event that proper administration of the Sweepstakes is prevented by such causes as contemplated above, Sponsor will pick the prize winner from all eligible, non-suspect entries received prior to such action.
